- Surveyed students, parents, and teachers spring

### District Preparation for External Review

- Completed self assessment based on survey results in summer 2012
  - A. Convened five (one per standard), diverse groups from District Five community
  - B. Identified strengths, disappointments/weaknesses
  - c. Rated each standard as 4, 3, 2 or 1
    - Used rubric to rate multiple indicators per standard
  - Developed narrative for each standard based on rating and input during self assessment
  - E. Identified evidence to support ratings for each standard
- Developed executive summary that tells district's story (published)
  - A. Description, purpose, achievements, and areas of improvement
- 5. Completed required, online ASSIST components
  - A. Adaptive System of School Improvement Support Tools

- Review evidence (artifacts)
  - Concrete document, policy, etc.
  - District practice
- Develop questions to ask and additional evidence to review

- > Finalize ratings and Exit Report
- Debrief superintendent
- Present Exit Report during called Board meeting
  - ➤ Typically 1:00 PM
