
A RESOLUTION

AUTHORIZING THE ISSUANCE AND SALE OF NOT EXCEEDING \$18,200,000 GENERAL OBLIGATION BONDS, SERIES 2015B, OF SCHOOL DISTRICT NO. 5 OF SPARTANBURG COUNTY, SOUTH CAROLINA, FIXING THE FORM AND CERTAIN DETAILS OF THE BONDS; AUTHORIZING THE SUPERINTENDENT OF THE SCHOOL DISTRICT AND CHAIRMAN OF THE BOARD OF TRUSTEES TO DETERMINE CERTAIN MATTERS RELATING TO THE BONDS; PROVIDING FOR THE PAYMENT OF THE BONDS AND THE DISPOSITION OF THE PROCEEDS THEREOF; AND OTHER MATTERS RELATING THERETO.

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF SCHOOL DISTRICT NO. 5 OF SPARTANBURG COUNTY, SOUTH CAROLINA, AS FOLLOWS:

SECTION 1. Definitions. Unless the context shall clearly indicate some other meaning, the terms defined in this Section shall have, for all purposes of this Resolution, the meanings hereinafter specified, with the definitions equally applicable to both the singular and plural forms and vice versa. The term:

“Beneficial Owner” shall mean any purchaser who acquires beneficial ownership interest in an Initial Bond held by the Depository. In determining any Beneficial Owner the School District, the Registrar and the Paying Agent may rely exclusively upon written representations made and information given to the School District, the Registrar and the Paying Agent, as the case may be, by the Depository or its Participants with respect to any Bond held by the Depository or its Participants in which a beneficial ownership interest is claimed.

“Board” shall mean the Board of Trustees of School District No. 5 of Spartanburg County, South Carolina.

“Bondholders” or the term “Holders” or any similar term shall mean the registered owner or owners of any outstanding Bond or Bonds.

“Book-Entry Form” or “Book-Entry System” shall mean with respect to the Bonds, a form or system, as applicable, under which (i) the ownership of beneficial interests in the Bonds may be transferred only through a book-entry and (ii) physical Bond certificates in fully registered form are registered only in the name of the Depository or its nominees as Holder, with the physical Bond certificates “immobilized” in the custody of the Depository. The book-entry maintained by the Depository is the record that identifies the owners of participatory interests in the Bonds, when subject to the Book-Entry System.

“Books of Registry” shall mean the registration books maintained by the Registrar in accordance with Section 9 hereof.

“Code” shall mean the Internal Revenue Code of 1986, as amended.

“Depository” shall mean any securities Depository that is a “clearing corporation” within the meaning of the New York Uniform Commercial Code and a “clearing agency” registered pursuant to the provisions of Section 17A of the Securities Exchange Act of 1934, operating and maintaining, with its Participants or otherwise, a Book-Entry System to record ownership of beneficial interests in the Bonds, and to effect transfers of the Bonds, in Book-Entry Form, and includes and means initially The Depository Trust Company (a limited purpose trust company), New York, New York.

“Government Obligations” shall mean, to the extent permitted by Section 6-5-10 of the South Carolina Code or any other authorization relating to the investment of funds of the School District, any of the following: (1) cash; (2) United States Treasury Obligations – State and Local Government Series; (3) United States Treasury bills, notes, bonds or zero coupon treasury bonds all as traded on the open market; (4) direct obligations of the U.S. Treasury which have been stripped by the Treasury itself, including CATS TIGRS and similar securities; (5) obligations of any agencies or instrumentalities which are backed by the full faith and credit of the United States of America; (6) bonds or debentures issued by any Federal Home Loan Bank or consolidated bonds or debentures issued by the Federal Home Loan Bank Board; (7) obligations of the Federal National Mortgage Association; (8) (i) general obligations of the State or any of its political units; or (ii) revenue obligations of the State or its political units, if at the time of investment, the obligor has a long term, unenhanced, unsecured debt rating in one of the top two ratings categories, without regard to a refinement or gradation of rating category by numerical modifier or otherwise, issued by at least two

nationally recognized credit rating agencies; or (9) any legally permissible combination of any of the foregoing. Government Obligations must be redeemable only at the option of the holder thereof.

“Initial Bonds” shall mean the Bonds initially issued in Book-Entry Form as provided in Section 6 hereof.

“Interest Payment Dates” shall mean September 1, 2015, and semiannually thereafter on March 1 and September 1 of each year.

“Letter of Representations” shall mean the Letter of Representations executed and delivered by the School District to the Depository.

“Participant” shall mean any bank, brokerage house or other financial institution for which, from time to time, the Depository effects book-entry transfers and pledges of securities deposited with the Depository.

“Paying Agent” shall mean Regions Bank in Columbia, South Carolina, or such other bank as may be designated by the Chairman of the Board or the District Superintendent pursuant to Section 4 hereof.

“Record Date” shall mean the fifteenth (15th) day of the month immediately preceding each Interest Payment Date on the Bonds or the date of notice of any proposed redemption of the Bonds.

“Registrar” shall mean Regions Bank in Columbia, South Carolina, or such other bank as may be designated by the Chairman of the Board or the District Superintendent pursuant to Section 4 hereof.

“Resolution” shall mean this Resolution.

“South Carolina Code” shall mean the Code of Laws of South Carolina 1976, as amended.

“School Bond Act” shall mean Title 59, Chapter 71, Article 1, Code of Laws of South Carolina 1976, as amended.

“School District” shall mean School District No. 5 of Spartanburg County, South Carolina.

“Series 2015B Bonds” shall mean the General Obligation Bonds, Series 2015B, in the aggregate principal amount of not exceeding \$18,200,000 authorized to be issued pursuant to Section 3 hereof.

“State” shall mean the State of South Carolina.

SECTION 2. Findings and Determinations. The Board of the School District hereby finds and determines:

(a) The School District was created by Order of Consolidation of the Spartanburg County Board of Education dated November 24, 1951, under which all school districts of Spartanburg County were consolidated into seven districts. The School District is a duly constituted body politic and political subdivision of the State of South Carolina.

(b) Pursuant to the provisions of Act No. 189 (1995 Acts), each of the seven boards of trustees of the school districts within Spartanburg County were vested and allocated with total fiscal autonomy. The Spartanburg County Board of Education (the “County Board”) was empowered to perform certain functions and all other powers, if any, formerly possessed by the County Board were

devolved upon the seven boards of trustees of the local districts of Spartanburg County. Pursuant to Act No. 499 (1998 Acts), those remaining powers and duties of the County Board were devolved upon the Spartanburg County Education Oversight Committee, and the County Board was abolished.

(c) Article X, Section 15 of the Constitution of the State of South Carolina, 1895, as amended (the "Constitution") provides that after November 30, 1982, the governing body of any school district may incur general obligation debt in an amount not exceeding eight percent (8%) of the assessed value of all taxable property of such school district upon such terms and conditions as the General Assembly may prescribe.

(d) The School Bond Act provides that the board of trustees of any school district may issue general obligation bonds of such school district for the purpose of defraying the cost of capital improvements to any amount not exceeding the constitutional debt limitation applicable to such school district. The School Bond Act requires the County Board of Education wherein the School District is located, if there is such, to approve the issuance of such bonds.

(e) The assessed value of all taxable property in the School District, as established by the last completed assessment thereof, is not less than \$227,924,313 which includes the 1987 assessed value for merchants' inventory in the amount of \$1,100,950. Eight percent (8%) of such sum is \$18,233,945. The outstanding general obligation debt of the School District is represented by the following:

(i) \$3,000,000 original principal amount General Obligation Bond, Series 2015A (the "2015A Bond"), dated April 1, 2015, maturing on July 1, 2015.

Thus, upon the payment of the 2015A Bond, the School District may incur \$18,233,945 of general obligation debt within its applicable constitutional debt limitation.

(f) Pursuant to the aforesaid provisions of the Constitution and laws of the State of South Carolina, it is now in the best interest of the School District for the Board to provide for the issuance and sale of the general obligation bonds in the principal amount of not exceeding \$18,200,000 for the purposes of defraying the costs of improvements, renovations and additions to and equipping James F. Byrnes High School and Lyman Elementary School.

SECTION 3. Authorization and Details of Series 2015B Bonds. Pursuant to the aforesaid provisions of the Constitution and laws of the State, there is hereby authorized to be issued not exceeding \$18,200,000 general obligation bonds of the School District to obtain funds for the purposes set forth in Section 2(f) above, including any engineering, architectural, financial and legal fees relating thereto and other incidental costs of issuing the Series 2015B Bonds. The Series 2015B Bonds shall be designated "\$18,200,000 [or original principal amount designated] General Obligation Bonds, Series 2015B, of School District No. 5 of Spartanburg County, South Carolina."

The Series 2015B Bonds shall be issued as fully registered bonds; shall be dated as of the date on which the Series 2015B Bonds are delivered to the initial purchaser(s) thereof or such other date as the Chairman of the Board determines; shall be in denominations of \$5,000 or any integral multiple thereof not exceeding the principal amount of the Series 2015B Bonds maturing in each year; shall bear interest (calculated on the basis of a 360-day year comprised of twelve 30-day months) payable on each Interest Payment Date at such rates as may be determined at the time of sale thereof by the Chairman of the Board or the District Superintendent at the time of the sale thereof; and shall mature in annual installments on March 1 of each year as determined by the Chairman of the Board and District Superintendent pursuant to Section 4 hereof.

Both the principal of and interest on the Series 2015B Bonds shall be payable in any coin or currency of the United States of America which is, at the time of payment, legal tender for public and private debts. Regions Bank in Columbia, South Carolina, is hereby designated as the Registrar and Paying Agent for the Series 2015B Bonds. The Spartanburg County Treasurer or a bank designated by the initial purchaser of the Series 2015 Bonds and approved by the Chairman of the Board or the District Superintendent may act as Paying Agent and Registrar for the Series 2015B Bonds.

SECTION 4. Chairman or Vice Chair of Board of Trustees or the District Superintendent to Determine Certain Matters. The Chairman of the Board (or in his absence, the Vice Chair) or the District Superintendent are hereby authorized and empowered to:

- (a) determine the original issue date of the Series 2015B Bonds;
- (b) determine the aggregate principal amount of the Series 2015B Bonds to be issued;
- (c) determine the first Interest Payment Date and the maturity dates of the Series 2015B Bonds and the respective principal amounts maturing on such dates;
- (d) determine whether the Series 2015B Bonds will be subject to redemption and, if so, determine the redemption terms and provisions;
- (e) determine whether any of the Series 2015B Bonds will be issued as term bonds and, if so, the principal amounts and maturity dates of the Series 2015B Bonds subject to mandatory sinking fund redemption;
- (f) designate the Paying Agent and Registrar for the Series 2015B Bonds, if different than as set forth in this Resolution;
- (g) determine the date and time of sale of the Series 2015B Bonds;
- (h) receive bids on behalf of the School District and award the sale of the Series 2015B Bonds to the lowest bidder therefor, in accordance with the terms of the Notice of Sale for the Series 2015B Bonds;
- (i) make adjustments to the principal amounts of the Series 2015B Bonds immediately following the sale thereof; and
- (j) negotiate and execute all other contracts which may be necessary or required in connection with the issuance of the Series 2015B Bonds.

After the sale of the Series 2015B Bonds, the Chairman of the Board or Vice Chair or the District Superintendent shall submit a written report to the Board setting forth the results of the sale of the Series 2015B Bonds.

SECTION 5. Redemption Provisions. As may be determined by the Chairman of the Board or the District Superintendent pursuant to Section 4 above, the Series 2015B Bonds may be subject to redemption at such times and upon such terms as they determine. The Series 2015B Bonds may be subject to redemption prior to maturity upon such terms and conditions as the Chairman of the Board or the District Superintendent and the purchaser thereof agree upon.

If less than all the Series 2015B Bonds of any maturity are called for redemption, the Series 2015B Bonds of such maturity to be redeemed shall be selected by lot by the Registrar. In the event the Series 2015B Bonds or any portion thereof shall be called for redemption, notice of the redemption, describing the Series 2015B Bonds to be redeemed, specifying the redemption date and the redemption price payable on such redemption, shall be mailed by first-class mail, postage prepaid, to the registered owner thereof as shown on the registry books of the School District kept by the Registrar not less than thirty (30) days and not more than sixty (60) days prior to the redemption date. The notice of redemption may state that the redemption of the Series 2015B Bonds being called for redemption is conditional upon the Paying Agent receiving on or before the redemption date of sufficient money for the redemption thereof. If the Series 2015B Bonds or any portion thereof shall have been duly called for redemption and notice of the redemption mailed as aforesaid, and if on or before the date fixed for redemption, payment thereof shall be duly made or provided for, interest on the Series 2015B Bonds to be redeemed shall cease to accrue from and after the redemption date specified in such notice.

SECTION 6. Book-Entry Bonds. If requested by the initial purchaser(s) of the Series 2015B Bonds, the Initial Bonds will be eligible securities for the purposes of the Book-Entry System of transfer maintained by the Depository, and transfers of beneficial ownership of the Initial Bonds shall be made only through the Depository and its participants in accordance with rules specified by the Depository. Such beneficial ownership must be of \$5,000 principal amount of Series 2015B Bonds of the same series and maturity or any integral multiple of \$5,000.

The Initial Bonds will be issued in fully-registered form, as a single Series 2015B Bond representing the entire principal amount of the Series 2015B Bonds or one Series 2015B Bond for each of the maturities of the Series 2015 Bonds, in the name of Cede & Co., as the nominee of the Depository. When any principal of, premium, if any, or interest on the Initial Bonds becomes due, the School District shall transmit or cause the Paying Agent to transmit to the Depository an amount equal to such installment of principal, premium, if any, and interest. Such payments will be made to Cede & Co. or other nominee of the Depository as long as it is owner of record on the applicable Record Date. Cede & Co. or other nominee of the Depository shall be considered to be the owner of the Initial Bonds so registered for all purposes of this Resolution, including, without limitation, payments as aforesaid and receipt of notices. The Depository shall remit such payments to the Beneficial Owners of the Series 2015B Bonds or their nominees in accordance with its rules and regulations.

Notices of redemption, if any, of the Initial Bonds or any portion thereof shall be sent to the Depository in accordance with the provisions of this Resolution.

The Depository is expected to maintain records of the positions of Participants in the Initial Bonds, and the Participants and persons acting through Participants are expected to maintain records of the Beneficial Owners in the Initial Bonds. The School District, the Paying Agent and the Registrar make no assurances that the Depository and its Participants will act in accordance with such rules or expectations on a timely basis, and the School District, the Paying Agent and the Registrar shall have no responsibility for any such maintenance of records or transfer of payments by the Depository to its Participants, or by the Participants or persons acting through Participants to the Beneficial Owners.

The School District, the Paying Agent and the Registrar may treat the Depository (or its nominee) as the sole and exclusive owner of the Series 2015B Bonds registered in its name for the purpose of payment of the principal of, premium, if any, or interest on the Series 2015B Bonds, giving any notice permitted or required to be given to Bondholders under this Resolution, registering the transfer of Series 2015B Bonds, obtaining any consent or other action to be taken by Bondholders and for all other purposes whatsoever, and shall not be affected by any notice to the contrary. The School District, the Paying Agent and the Registrar shall not have any responsibility or obligation to any Participant, any person claiming a beneficial ownership

interest in the Series 2015B Bonds under or through the Depository or any Participant, or any other person which is not shown on the Books of Registry of the School District maintained by the Registrar as being a Bondholder, with respect to: the accuracy of any records maintained by the Depository or any Participant or the maintenance of any records; the payment by the Depository or any Participant of any amount in respect of the principal of, premium, if any, or interest on the Series 2015B Bonds; the sending of any transaction statements; the delivery or timeliness or delivery by the Depository or any Participant of any notice which is permitted or required to be given to Bondholders thereunder; the selection of Bondholders to receive payments upon any partial redemption of the Series 2015B Bonds; or any consent given or other action taken by the Depository as a Bondholder.

SECTION 8. Successor Depository. If (a) the Depository determines not to continue to act as securities depository for the Series 2015B Bonds and gives reasonable notice to the Registrar and the School District, or (b) the School District has advised the Depository of the School District's determination that the Depository is incapable of discharging its duties, then the School District shall attempt to retain another qualified securities depository to replace the Depository. Upon receipt by the School District or the Registrar of the Initial Bonds together with an assignment duly executed by the Depository, the School District shall execute and deliver to the successor Depository the Series 2015B Bonds of the same principal amount, interest rate, redemption provisions, if any, and maturity. If the School District is unable to retain a qualified successor to the Depository, or the School District has determined that it is in its best interest not to continue the Book-Entry System of transfer or that interests of the Beneficial Owners of the Series 2015B Bonds might be adversely affected if the Book-Entry System of transfer is continued (the School District undertakes no obligation to make any investigation to determine the occurrence of any events that would permit it to make any such determination), and has made provision to so notify Beneficial Owners of the Series 2015B Bonds by mailing an appropriate notice to the Depository, upon receipt by the School District of the Initial Bonds together with an assignment duly executed by the Depository, the School District shall execute, authenticate and deliver to the Depository Participants' Bonds in fully-registered form, in substantially the form set forth in Section 13 of this Resolution in the denomination of \$5,000 or any integral multiple thereof.

SECTION 9. Registration, Transfer and Exchange of Series 2015B Bonds. The School District shall cause Books of Registry to be kept at the offices of the Registrar, for the registration and transfer of the Series 2015B Bonds. Upon presentation at its office for such purpose, the Registrar shall register or transfer, or cause to be registered or transferred, on such Books of Registry, the Series 2015B Bonds under such reasonable regulations as the Registrar may prescribe.

Each Series 2015B Bond shall be transferable only upon the Books of Registry of the School District, which shall be kept for such purpose at the principal office of the Registrar, by the registered owner thereof in person or by his duly authorized attorney upon surrender thereof together with a written instrument of transfer satisfactory to the Registrar duly executed by the registered owner or his duly authorized attorney. Upon the transfer of any such Series 2015B Bond, the Registrar on behalf of the School District shall issue in the name of the transferee a new fully registered Series 2015B Bond or Series 2015B Bonds of the same aggregate principal amount, interest rate and maturity as the surrendered Series 2015B Bond. Any Series 2015B Bond surrendered in exchange for a new registered Series 2015B Bond pursuant to this Section shall be canceled by the Registrar.

The School District, the Registrar and the Paying Agent may deem or treat the person in whose name any fully registered Series 2015B Bond shall be registered upon the Books of Registry as the absolute owner of such Series 2015B Bond, whether such Series 2015B Bond shall be overdue or not, for the purpose of receiving payment of the principal of and interest on such Series 2015B Bond and for all other purposes and all such payments so made to any such registered owner or upon his order and shall be valid and effectual to satisfy and discharge the liability upon such Series 2015B Bond to the extent of the sum or sums so paid, and neither the School District nor the Registrar or the Paying Agent shall be affected by any notice to the

contrary. In all cases in which the privilege of transferring Series 2015B Bonds is exercised, the School District shall execute and the Registrar shall authenticate and deliver Bonds in accordance with the provisions of this Resolution. Neither the School District nor the Registrar/Paying Agent shall be obliged to make any such transfer of Series 2015B Bonds during the fifteen (15) days preceding an Interest Payment Date on such Series 2015B Bonds.

SECTION 10. Record Date. The School District hereby establishes a record date for the payment of interest or for the giving of notice of any proposed redemption of Series 2015B Bonds (the "Record Date"), and such Record Date shall be not more than fifteen (15) days preceding an Interest Payment Date on such Bond or, in the case of any proposed redemption of Series 2015B Bonds, such Record Date shall not be more than fifteen (15) days prior to the mailing of notice of redemption of Series 2015B Bonds.

SECTION 11. Mutilation, Loss, Theft or Destruction of Series 2015B Bonds. In case any Series 2015B Bond shall at any time become mutilated in whole or in part, or be lost, stolen or destroyed, or be so defaced as to impair the value thereof to the owner, the School District shall execute and the Registrar shall authenticate and deliver at the principal office of the Registrar, or send by registered mail to the owner thereof at his request, risk and expense a new Series 2015B Bond of the same series, interest rate and maturity and of like tenor and effect in exchange or substitution for and upon the surrender for cancellation of such defaced, mutilated or partly destroyed Series 2015B Bond, or in lieu of or in substitution for such lost, stolen or destroyed Bond. In any such event, the applicant for the issuance of a substitute Series 2015B Bond shall furnish the School District and the Registrar evidence or proof satisfactory to the School District and the Registrar of the loss, destruction, mutilation, defacement or theft of the original Series 2015B Bond, and of the ownership thereof, and also such security and indemnity as may be required by the laws of the State of South Carolina or such greater amount as may be required by the School District and the Registrar. Any duplicate Series 2015B Bond issued under the provisions of this Section in exchange and substitution for any defaced, mutilated or partly destroyed Series 2015B Bond or in substitution for any allegedly lost, stolen or wholly destroyed Series 2015B Bond shall be entitled to the identical benefits under this Resolution as was the original Series 2015B Bond in lieu of which such duplicate Series 2015B Bond is issued, and shall be entitled to equal and proportionate benefits with all the other Series 2015B Bonds of the same series issued hereunder.

All expenses necessary for the providing of any duplicate Series 2015B Bond shall be borne by the applicant therefor.

SECTION 12. Execution of Series 2015B Bonds. The Series 2015B Bonds shall be executed in the name of the School District with the manual or facsimile signature of the Chairman of the Board (or in his or her absence, the Vice Chair of the Board) attested by the manual or facsimile signature of the Secretary of the Board under a facsimile of the seal of the School District which shall be impressed, imprinted or reproduced thereon. The Series 2015B Bonds shall not be valid or become obligatory for any purpose unless there shall have been endorsed thereon a certificate of authentication. Each Series 2015B Bond shall bear a certificate of authentication manually executed by the Registrar in substantially the form set forth herein.

SECTION 13. Form of Series 2015B Bonds. The Series 2015B Bonds shall be in substantially the following form. In the event the Series 2015B Bonds will be held by a single Bondholder, the form of bond may be revised as a single fully registered bond which sets forth any or all maturing principals amounts:

KNOW ALL MEN BY THESE PRESENTS, that School District No. 5 of Spartanburg County, South Carolina (the "School District"), is justly indebted and, for value received, hereby promises to pay to the Registered Holder (named above), or registered assigns, the principal amount shown above on the maturity date shown above (unless the within Bond shall be subject to prior redemption and shall have been duly called for previous redemption and payment of the redemption price made or provided for), upon presentation and surrender of this Bond at the principal office of Regions Bank, as paying agent (the "Paying Agent"), in Columbia, South Carolina, and to pay interest on such principal sum from the date hereof at the interest rate per annum shown above (calculated on the basis of a 360-day year comprised of twelve 30-day months) until this Bond matures or is earlier redeemed. Interest on this Bond is payable on September 1, 2015, and semiannually thereafter on March 1 and September 1 of each year until this Bond matures or is earlier redeemed, and shall be payable by check or draft mailed to the person in whose name this Bond is registered on the registration books of the School District maintained by Regions Bank, as registrar (the "Registrar"), in Columbia, South Carolina, at the close of business on the fifteenth (15th) day of the calendar month preceding each semiannual interest payment date or proposed redemption (the "Record Date"). The principal, redemption premium, if any, and interest on this Bond are payable in any coin or currency of the United States of America which is, at the time of payment, legal tender for public and private debts; provided, however, that interest on this fully registered Bond shall be paid by check or draft as set forth above.

This Bond shall not be entitled to any benefit under the Resolution of the School District authorizing the Bonds, nor become valid or obligatory for any purpose, until the Certificate of Authentication hereon shall have been duly executed by the Registrar.

For the payment of the principal and interest on this Bond as they respectively mature and for the creation of such sinking fund as may be necessary therefor the full faith, credit, resources and taxing power of the School District are hereby irrevocably pledged and there shall be levied annually by the Auditor of Spartanburg County and collected by the Treasurer of Spartanburg County in the same manner as county taxes are levied and collected, a tax, without limit, on all taxable property in the School District sufficient to pay the principal and interest of this Bond as they respectively mature and to create such sinking fund as may be necessary therefor.

SECTION 14. Security for Series 2015B Bonds. The full faith, credit, resources and taxing power of the School District are hereby irrevocably pledged for the payment of the principal and interest on the Series 2015B Bonds as they respectively mature and for the creation of such sinking fund as may be necessary therefor. There shall be levied annually by the Auditor of Spartanburg County, and collected by the Treasurer of Spartanburg County, in the same manner as county taxes are levied and collected, a tax, without limit, on all taxable property in the School District sufficient to pay the principal and interest of the Bonds as they respectively mature and to create such sinking fund as may be necessary therefor.

All expenses in relation to the printing of CUSIP identification numbers on the Series 2015B Bonds shall be paid for by the School District provided, however, that the CUSIP Service Bureau charge for the assignment of said numbers shall be the responsibility of and shall be paid for by the successful bidder.

SECTION 18. Preliminary and Final Official Statement. The Board hereby authorizes and directs the District Superintendent to prepare, or cause to be prepared, a Preliminary Official Statement to be distributed to prospective purchasers of the Series 2015B Bonds together with the Notice of Sale. The Board authorizes the District Superintendent to designate the Preliminary Official Statement as “near final” for purposes of Rule 15c2-12 of the Securities Exchange Commission. The District Superintendent is further

authorized to see to the completion of the final form of the Official Statement upon the sale of the Series 2015B Bonds so that it may be provided to the purchaser of the Series 2015B Bonds.

SECTION 19. Continuing Disclosure. The School District hereby covenants and agrees that it will comply with and carry out all of the provisions of a Continuing Disclosure Certificate, in substantially the form attached hereto as Exhibit A. Notwithstanding any other provisions of this Resolution, failure of the School District to comply with the Continuing Disclosure Certificate shall not be considered an event of default, and no liability for damages shall attach therefor. The sole remedy for such failure to comply shall be that any Bondholder may take such actions as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the School District to comply with its obligations under this Section. The District Superintendent or the Director of Finance is hereby authorized to establish written procedures relating to the School District's continuing disclosure obligations in connection with the Series 2015B Bonds.

SECTION 20. Filings with Central Repository. In accordance with Section 11-1-85 of the South Carolina Code, the School District covenants that it will file or cause to be filed with a central repository for further availability in the secondary bond market when requested: (a) a copy of the annual audit of the School District within thirty (30) days of the School District's receipt thereof; and (b) within thirty (30) days of the occurrence thereof, relevant information of an event which, in the opinion of the School District, adversely affects more than five (5%) of the School District's revenue or its tax base.

SECTION 21. Deposit and Use of Proceeds. The proceeds derived from the sale of the Bonds must be deposited with the Treasurer of Spartanburg County in a special fund to the credit of the School District and must be applied solely to the purposes for which the Series 2015B Bonds were issued, including payment of costs of issuance of the Series 2015B Bonds, except that the accrued interest, if any, must be used to discharge in part the first interest to become due on the Series 2015B Bonds.

SECTION 22. Federal Tax Covenants. The School District hereby covenants and agrees with the holders of the Series 2015B Bonds that it will not take any action which will, or fail to take any action which failure will, cause interest on the Series 2015B Bonds to become includable in the gross income of the bondholders for federal income tax purposes pursuant to the provisions of the Code and regulations promulgated thereunder in effect on the date of original issuance of the Series 2015B Bonds and that no use of the proceeds of the Series 2015B Bonds shall be made which, if such use had been reasonably expected on the date of issue of the Series 2015B Bonds would have caused the Series 2015B Bonds to be "arbitrage bonds", as defined in Section 148 of the Code, and to that end the School District hereby shall:

(a) comply with the applicable provisions of Section 103 and Sections 141 through 150 of the Code and any regulations promulgated thereunder so long as the Series 2015B Bonds are outstanding;

(b) establish such funds, make such calculations and pay such amounts, in the manner and at the times required in order to comply with the requirements of the Code relating to required rebates of certain amounts to the United States; and

(c) make such reports of such information at the time and places required by the Code.

The District Superintendent or the Director of Finance is hereby authorized to adopt written procedures to ensure the School District's compliance with federal tax matters relating to the Series 2015B Bonds and other federal tax exempt debt heretofore or hereafter issued by the School District.

SECTION 23. Miscellaneous. To the extent deemed advisable, the Board hereby authorizes the District Superintendent and the financial advisor to submit applications to municipal bond insurance

companies for bond insurance or other credit enhancements relating to the Series 2015B Bonds. The District Superintendent is hereby authorized to accept on behalf of the School District the proposal deemed most advantageous to the School District. The Board hereby authorizes the Chairman and Secretary of the Board, the District Superintendent and the Director of Finance to execute such documents and instruments as may be necessary to effect the issuance of the Series 2015B Bonds or make modifications in any documents including but not limited to the form of the Bond or Notice of Sale. The Board hereby authorizes the District Superintendent, with the assistance of the financial advisor, to negotiate the terms of, and execute in the name and on behalf of the School District, investment agreements, forward delivery agreements, repurchase agreements and other agreements in connection with the Series 2015B Bonds, to prepare and solicit bids for providers of such agreements and to execute, in the name and on behalf of the School District, written confirmations of any such agreements and other documents as may be necessary in connection therewith. The Board hereby authorizes the District Superintendent to retain McNair Law Firm, P.A. as bond counsel, and Compass Municipal Advisors, LLC as financial advisor, in connection with the issuance of the Series 2015B Bonds.

SECTION 24. Declaration of Intent to Reimburse Certain Expenditures. This Resolution shall constitute the School District's declaration of official intent pursuant to Regulation §1.150-2 of the Code to reimburse the School District from a portion of the proceeds of the Series 2015B Bonds for expenditures it anticipates incurring (the "Expenditures") with respect to the projects prior to the execution and delivery of the Series 2015B Bonds. The Expenditures which are reimbursed are limited to Expenditures which are: (a) properly chargeable to a capital account (or would be so chargeable with a proper election or with the application of the definition of placed in service under Regulation §1.150-2 of the Code) under general federal income tax principals; or (2) certain de minimis or preliminary Expenditures satisfying the requirements of Regulation §1.150-2(f) of the Code. The source of funds for the Expenditures with respect to the acquisition of the Equipment will be the School District's general funds. To be eligible for reimbursement of the Expenditures, the reimbursement allocation must be made not later than 18 months after the later of (a) the date on which the Expenditures were paid; or (b) the date such projects were placed in service, but in no event more than three (3) years after the original Expenditures.

SECTION 25. Repeal of Conflicting Resolutions. All rules, regulations, resolutions and parts thereof, procedural or otherwise, in conflict herewith or the proceedings authorizing the issuance of the Series 2015B Bonds are, to the extent of such conflict, hereby repealed and this Resolution shall take effect and be in full force from and after its adoption.

EXHIBIT A

FORM OF CONTINUING DISCLOSURE CERTIFICATE

This Continuing Disclosure Certificate (the "Disclosure Certificate") is executed and delivered by School District No. 5 of Spartanburg County, South Carolina (the "School District") in connection with the issuance of \$18,200,000 original principal amount General Obligation Bonds, Series 2015B, (the "Series 2015B Bonds"). The Series 2015B Bonds are being issued pursuant to a Resolution adopted by the Board of Trustees of the School District on May 11, 2015 (the "Resolution"). The School District covenants and agrees as follows:

SECTION 1. Purpose of the Disclosure Certificate. This Disclosure Certificate is being executed and delivered by the School District for the benefit of the beneficial owners and in order to assist the Participating Underwriters (defined below) in complying with the Rule (defined below).

SECTION 2. Definitions. The following capitalized terms shall have the following meanings:

"**Annual Report**" shall mean any Annual Report provided by the School District pursuant to, and as described in, Sections 3 and 4 of this Disclosure Certificate.

"**Dissemination Agent**" shall mean the School District or any successor Dissemination Agent designated in writing by the School District and which has filed with the School District a written acceptance of such designation.

"**Listed Events**" shall mean any of the events listed in Section 5(a) of this Disclosure Certificate.

"**National Repository**" shall mean for purposes of the Rule, the Electronic Municipal Market Access (EMMA) system created by the Municipal Securities Rulemaking Board or any successor National Repositories as determined by the Securities and Exchange Commission.

"**Participating Underwriter**" shall mean _____ and any other original underwriter of the Series 2015B Bonds required to comply with the Rule in connection with offering of the Series 2015B Bonds.

"**Repository**" shall mean the National Repository and the State Depository, if any.

"**Rule**" shall mean Rule 15c2-12(b)(5) adopted by the Securities and Exchange Commission under the Securities Exchange Act of 1934, as the same may be amended from time to time.

"**Series 2015B Bonds**" shall mean the \$18,200,000 original principal amount General Obligation Bonds, Series 2015B, of School District No. 5 of Spartanburg County, South Carolina, dated _____, 2015.

"**State Depository**" shall mean any public or private repository or entity designated by the State of South Carolina as a state depository for the purpose of the Rule. As of the date of this Certificate, there is no State Depository.

SECTION 3. Provision of Annual Reports.

(a) The School District shall, or shall cause the Dissemination Agent to provide, not later than February 1 of each year, commencing in 2016, to each Repository an Annual Report which is consistent with the requirements of Section 4 of this Disclosure Certificate. Not later than fifteen (15) business days prior to such date the School District shall provide the Annual Report to the Dissemination Agent, if other than the School District; provided, that if the audited financial statements required pursuant to Section 4 hereof to be included in the Annual Report are not available for inclusion in the Annual Report as of such date, unaudited financial statements of the School District may be included in such Annual Report in lieu thereof, and the School District shall replace such unaudited financial statements with audited financial statements within fifteen (15) days after such audited financial statements become available for distribution. The Annual Report may be submitted as a single document or as separate documents comprising a package, and may cross-reference other information as provided in Section 4 of this Disclosure Certificate; provided that the audited financial statements of the School District may be submitted separately from the balance of the Annual Report.

(b) If the School District is unable to provide to the Repository an Annual Report by the date required in subsection (a), the School District shall send a notice to the National Repository, the Municipal Securities Rulemaking Board, and State Depository, if any, in substantially the form attached hereto as Exhibit A.

(c) The Dissemination Agent shall:

(1) determine each year prior to the date for providing the Annual Report the name and address of the National Repository and the State Depository, if any; and

(2) if the Dissemination Agent is other than the School District, file a report with the School District and (if the Dissemination Agent is not the Registrar) the Registrar certifying whether the Annual Report has been provided pursuant to this Disclosure Certificate, and, if provided, stating the date it was provided, and listing all the Repositories to which it was provided.

SECTION 4. Content of Annual Reports. The School District's Annual Report shall contain or incorporate by reference the following:

(a) The Audited Financial Statements for the fiscal year ended on the previous June 30, prepared in conformity with generally accepted accounting principles applicable as promulgated to apply to governmental entities from time to time by the Governmental Accounting Standards Board (or if not in conformity, to be accompanied by a qualitative discussion of the differences in the accounting principles and the impact of the change in the accounting principles on the presentation of financial information). If the School District's audited financial statements are not available by the time the Annual Report is required to be filed pursuant to Section 3(a), the Annual Report shall include unaudited financial statements in a format similar to the financial statements contained in the Official Statement dated _____, relating to the Series 2015B Bonds (the "Official Statement"), and the audited financial statements shall be filed in the same manner as the Annual Report within 15 days after said financial statements become available.

(b) Financial information relating to the School District's General Fund revenues and expenditures for the previous five fiscal years, prepared substantially in the form of and updating the table appearing in the Official Statement under the heading, "FINANCIAL INFORMATION--General Fund-Five Year Summary."

(c) Information concerning the School District's budget for the fiscal year in which the Annual Report is issued, prepared substantially in the form of the summary shown in the Official Statement under the heading, "FINANCIAL INFORMATION -- General Fund Budget."

(d) Information concerning the Education Finance Act of 1977 and the Education Improvement Act of 1984 for the fiscal year in which the Annual Report is issued, prepared in substantially the form of the tables shown in the Official Statement under the heading, "SCHOOL DISTRICT--Education Finance Act of 1977 and Education Improvement Act of 1984."

(e) (i) Information concerning the assessed value of taxable real and personal property in the School District for each of the five previous fiscal years and if available from the auditor of Spartanburg County, an estimate for the fiscal year in which the Annual Report is issued, prepared substantially in the form and updating the tables shown in the Official Statement under the heading, "TAX INFORMATION--Assessed Value of Taxable Property."

(f) Information showing the *ad valorem* property taxes collected for the School District for each of the five previous fiscal years prepared substantially in the form of and updating the table shown in the Official Statement under the heading, "TAX INFORMATION --Tax Collections"; and (ii) information concerning the ten largest taxpayers in the School District and the amounts of School District taxes paid during the previous fiscal year, prepared substantially in the form of the table shown in the Official Statement under the heading, "TAX INFORMATION--Ten Largest Taxpayers."

(g) Information showing the legal debt limit of the School District as of June 30 of the previous fiscal year or some later date, substantially in the form shown in the Official Statement under the heading, "DEBT STRUCTURE--Legal Debt Limit of the School District" and (ii) information showing the outstanding indebtedness of the School District, including long-term lease obligations and other long-term liabilities, as of June 30 of the previous fiscal year or some later date, substantially in the form of and updating the table and information in the Official Statement under the heading, "DEBT STRUCTURE--Outstanding Indebtedness--Description of General Obligation Indebtedness by Issue--Capital Lease Obligations--Other School District Debt," and the composite debt service table in the Official Statement under the heading, "DEBT STRUCTURE--Composite Debt Service."

Any or all of the items listed above may be incorporated by reference from other documents, including official statements of debt issues with respect to which the School District is an "obligated person" (as defined by the Rule), which have been filed with the Repository or the Securities and Exchange Commission. If the document incorporated by reference is a final official statement, it must be available from the National Repository. The School District shall clearly identify each such other document so incorporated by reference. The School District may discharge its undertaking described above by transmitting the documents referred to above to any entity and by any method authorized by the Securities and Exchange Commission.

SECTION 5. Format of Annual Report. The Annual Report (including the audited financial statements of the School District) shall be submitted to the National Repository as portable document format (PDF) files configured to permit documents to be saved, viewed, printed and retransmitted by electronic means and must be word-searchable (that is, allowing the user to search for specific terms used within the document through a search or find function available in most standard software packages).

SECTION 6. Reporting of Significant Events.

(a) This Section 6 shall govern the giving of notices of the occurrence of any of the following events (the "Listed Events"):

- (1) Principal and interest payment delinquencies;
- (2) Non-payment related defaults;
- (3) Unscheduled draws on debt service reserves reflecting financial difficulties;
- (4) Unscheduled draws on credit enhancements reflecting financial difficulties;
- (5) Substitution of credit or liquidity providers, or their failure to perform;
- (6) Adverse tax opinions, the issuance by the Internal Revenue Service of proposed or final determinations of taxability, Notices of Proposed Issue (IRS Form 5701-TEB) or other material notices or determinations with respect to the tax status of the security, or other material events affecting the tax status of the security;
- (7) Modifications to rights of security holders;
- (8) Bond calls;
- (9) Tender offers;
- (10) Defeasances;
- (11) Release, substitution, or sale of property securing repayment of the securities;
- (12) Rating changes;
- (13) Bankruptcy, insolvency, receivership or similar event of the School District;
- (14) The consummation of a merger, consolidation, or acquisition involving the School District or the sale of all or substantially all of the assets of the School District other than in the ordinary course of business, the entry into a definitive agreement to undertake such an action or the termination of a definitive agreement relating to any such actions, other than pursuant to its terms;
- (15) Appointment of a successor or additional trustee, or the change of name of a trustee.

(b) Whenever the School District obtains knowledge of the occurrence of a Listed Event described in subsections (a)(2), (7), (8), (11), (14), or (15) above, the School District shall as soon as possible determine if such event would be material under applicable federal securities laws. If the School District determines that knowledge of the occurrence of such event would be material under applicable federal securities laws, the School District shall promptly, and no later than 10 days after the occurrence of the event, file a notice of such occurrence with the Municipal Securities Rulemaking Board and the State Depository.

(c) Whenever the School District obtains knowledge of the occurrence of a Listed Event described in subsections (a)(1), (3), (4), (5), (6), (9), (10), (12), or (13) above, the School District shall promptly, and no later than 10 days after the occurrence of the event, file a notice of such occurrence with the Municipal Securities Rulemaking Board and the State Depository.

(d) Notwithstanding the foregoing, notice of Listed Events described in subsections (a)(8), (9), and (10) above need not be given under this subsection any earlier than the notice (if any) of the underlying event is given to owners of affected Series 2015B Bonds. For the purposes of the event identified in (a)(13) above, the event is considered to occur when any of the following occur: the appointment of a receiver, fiscal agent or similar officer for the School District in a proceeding under the U.S. Bankruptcy Code or in any other proceeding under state or federal law in which a court or governmental authority has assumed jurisdiction over substantially all of the assets or business of the School District, or if such jurisdiction has been assumed by leaving the existing governing body and officials or officers in possession but subject to the supervision and orders of a court or governmental authority, or the entry of an order confirming a plan of reorganization, arrangement or liquidation by a court or governmental authority having supervision or jurisdiction over substantially all of the assets or business of the School District.

SECTION 7. Termination of Reporting Obligation. The School District's obligations under this Disclosure Certificate shall terminate upon the defeasance, prior redemption or payment in full of all of the Series 2015B Bonds.

SECTION 8. Dissemination Agent. The School District may, from time to time, appoint or engage a Dissemination Agent to assist it in carrying out its obligations under this Disclosure Certificate, and may discharge any such Agent, with or without appointing a successor Dissemination Agent. The initial Dissemination Agent shall be the School District.

SECTION 9. Amendment; Waiver. Notwithstanding any other provision of this Disclosure Certificate, the School District may amend this Disclosure Certificate and any provision of this Disclosure Certificate may be waived, if such amendment or waiver is supported by an opinion of counsel expert in federal securities laws acceptable to the School District, to the effect that such amendment or waiver would not, in and of itself, cause the undertakings herein to violate the Rule if such amendment or waiver had been effective on the date hereof but taking into account any subsequent change in or official interpretation of the Rule.

SECTION 10. Additional Information. Nothing in this Disclosure Certificate shall be deemed to prevent the School District from disseminating any other information, using the means of dissemination set forth in this Disclosure Certificate or any other means of communication, or including any other information in any Annual Report or notice of occurrence of a Listed Event, in addition to that which is required by this Disclosure Certificate. If the School District chooses to include any information in any Annual Report or notice of occurrence of a Listed Event, in addition to that which is specifically required by this Disclosure Certificate, the School District shall have no obligation under this Disclosure Certificate to update such information or include it in any future Annual Report or notice of occurrence of a Listed Event.

SECTION 11. Default. In the event of a failure of the School District, or the Dissemination Agent to comply with any provision of this Disclosure Certificate, any beneficial owner may take such actions as may be necessary and appropriate, including seeking injunctive relief or specific performance by court order, to cause the School District, or the Dissemination Agent, as the case may be, to comply with its obligations under this Disclosure Certificate. A default under this Disclosure Certificate shall not be deemed an event of default under the Bond Resolution, and the sole remedy under this Disclosure Certificate in the event of any failure of the School District, or the Dissemination Agent to comply with this Disclosure Certificate shall be an action to compel performance.

SECTION 12. Duties, Immunities and Liabilities of Dissemination Agent. The provisions of this Section 12 shall apply if the School District is not the Dissemination Agent. The Dissemination Agent shall have only such duties as are specifically set forth in this Disclosure Certificate, and to the extent permitted by applicable law and other public policy considerations, the School District agrees to indemnify and save the Dissemination Agent, its officers, directors, employees and agents, harmless against any loss, expense and liabilities which they may incur arising out of or in the exercise or performance of their powers and duties hereunder, including the costs and expenses (including attorneys' fees) of defending against any claim of liability, but excluding liabilities due to the Dissemination Agent's negligence or willful misconduct. The obligations of the School District under this Section shall survive resignation or removal of the Dissemination Agent and payment of the Series 2015B Bonds.

SECTION 13. Beneficiaries. This Disclosure Certificate shall inure solely to the benefit of the School District, the Dissemination Agent, the Participating Underwriters, and Holders from time to time of the Series 2015B Bonds and shall create no rights in any other person or entity.
